While I am not aware of the details of the recent accident which took place at this junction some 3 weeks ago, it is of concern that the street signage which was completely wrecked in this accident which also included the No Entry sign have still not been removed and replaced. For motorists therefore the only obvious signage that this is a no entry is by road markings which are not always obviously visible.
